We got stop notice from Mining & Geology Department on 12/10/2019 for the reason that we have not obtained prior clearances from the Standing Committee of the National Board for Wildlife . Our unit located 8 km away from Chulanur Peafowl sanctuary. No mining activities since 12/10/2019

## Other periodical compliance as per below:

- (a) No industrial waste generation during the course of process so far.
- (b) Controlled blasting techniques are used.
- (c) No dust generation during drilling since wet drilling methods are adopted.
- (d) Proper maintenance of machineries are carried out periodically.
- (e) Conducted periodical monitoring of sound as well as noise by the approved agency. Noise level & air quality maintained in the permissible standard limit. (report enclosed)
- (f) Sprinklers are also installed to control the dust emission.
- (g) Enough trees are planted in the area.
- (h) Survey number 1860/1 fully excluded from the mining area.
- (i) Excavated pit area maintained and retained as water storage area.
- (j) Warning alarm as well as blasting time are displayed at the site and licensed blast man conducting blasting operations at the site.
- (k) No mining operations at places having a slope greater than 45
- (l) Obtained all statutory licenses from different departments concerned including consent to operate from KSPCB.
